



2024-2025 Expected Grant Awards

10 Cents a Meal for Michigan’s Kids and Farms provides grant funds to pay for Michigan-grown food, local food transportation fees, and food service labor expenses to strengthen the local food supply chain and enrich nutrition and educational experiences for children. Eligible grantees include schools, early care and education centers, and other institutions that participate in Child Nutrition Programs in Michigan. The grantees listed below applied for the grant by September 18, 2024, and their application responses were scored out of 30 points, using the [application rubric](#). Successful applicants were grouped based on their application scores and awarded grants of whichever was less – the applicant’s requested budget or a percentage of their maximum possible grant award*, as below:

- Grantees that scored 26-30 points received up to 60% of their maximum possible grant award.
- Grantees that scored 23-25 points received up to 47.5% of their maximum possible grant award.
- Grantees that scored 20-22 points received up to 35% of their maximum possible grant award.
- Grantees that scored 16-19 points received up to 22.5% of their maximum possible grant award.
- Grantees that scored 0-15 points received up to 10% of their maximum possible grant award.

* The maximum possible grant award is equal to 10 percent of the total number of meals served in Child Nutrition Programs during Fiscal Year 2023
